### PRESIDENTIAL DECREE No: 16

### "Consular fees and royalties"

### THE PRESIDENT OF THE HELLENIC REPUBLIC

### Considering:

- **1.** Articles 52, 53 and 60 of the Organisation Statute of the Ministry of Foreign Affairs, ratified by the first article of Law 3566/2007 "Ratification as a Code of 'the Organisation Statute of the Ministry of Foreign Affairs' (A' 117)
- **2.** Articles 1, 2 para 1 and 5 para.1 of Law 2949/2001 "Consular Charges and other provisions" (A' 243).
- **3.** The Presidential Decree 116/2002 "Consular fees and royalties" (A' 96) as modified and in force.
- **4.** Article 1 of Law3103/2003 "Issuance of passports by the Greek Police and other provisions" (A' 23) and the Joint Ministerial Decision No: 3021/22/10/28.06.2005 "Justificatory documents and procedure for issuance, form and content of the indications of a passport" (B' 932).
- **5.** Regulation E.U. 265/2010 of the European Parliament and the Council, concerning the modification of the Application Convention of the Schengen Agreement and Regulation E.C. 562/2006, concerning the circulation of persons with long-term visa.
- **6.** Law 2968/2001 "Ratification of the Decisions of the Representatives of the Governments of the Member States, convened in the framework of the Council of the European Union concerning the protection of E.U citizens, on the part of diplomatic and consular missions and on the establishment of the emergency travel document (A´ 280), which ratified the Decision No: ESDP 96/409 of the Representatives of the Governments of the Member States, who convened in the framework of the Council of June 25<sup>th</sup> 1996, on the establishment of the emergency travel document.
- **7.** Decision No: Y48/09.07.2012 of the Prime Minister "Determination of the competencies of the Alternate Minister of Finance Christos STAIKOURAS" (B' 2105)
- **8.** Article 90 of the Code of Legislation on the Government and the governmental bodies, which was ratified by Article 1 of P.D. 63/2005

- "Codification of the legislation on the Government and the governmental bodies" (A $^{\prime}$ 98)
- **9.** The fact that the application of the provisions of this Decree does not create any expenditure for the State budget
- **10.** The Opinion of the Council of State No. 179/2013, at the request of the Minister of Foreign Affairs and the Alternate Minister of Finance

We hereby resolve:

# Article 1 Definition of Consular Fees

For the purposes of the present Presidential Decree:

- **a.** Consular authorities are: General Consulates and Consulates, Consular Offices of Embassies and Consular Port Authorities.
- **b.** Honorary consular authorities are: Honorary General Consulates and Consulates.

# Article 2 Fees for Consular Deeds

The compensatory consular fees of article 1 of Law 2949/2001, collected by consular authorities for deeds or actions issued or undertaken during the performance of their duties are determined as follows:

### A3 <u>Issuance of Greek Passports</u>

Consular authorities receive the applications and collect the fees for the issuance of Greek passports in accordance with the provisions of Law 3103/2003 and the joint ministerial decision 3021/22/10/2005/28.06.2005, as modified and in force.

Travel documents are issued in exceptional cases and provided that the timely issuance of a regular passport is not feasible.

### A4 <u>Visas on foreign passports</u>

a) Consular authorities grant to holders of foreign passports the categories of entry visas provided for by the Convention Implementing the Schengen Agreement in accordance with the conditions, the procedure and following the payment of visa fees set by the aforesaid Convention or the acts concerning its implementation and the Regulation (E.P) no: 810/2009 of the European Parliament and the Council of July 13<sup>th</sup>, 2009 for the establishment of a Community Code on Visas.

Visas are granted GRATIS under the terms and conditions determined by the joint ministerial decision 2/63542/A0024/05.11.2002, as modified and in force.

On the basis of reciprocity, visas on diplomatic and official passports of foreign nationals are granted GRATIS.

# Article 3 Receipts in favour of individuals

A sum equal to 2% is paid in favour of the state for each collection of money at the request of an individual, by virtue of a court decision or other title.

### Article 4 Receipt acknowledged by Payment Slip

- 1. When consular fees exceeding, per deed, EUR 300 are collected, a Payment Slip (Γραμμάτειο Είσπραξης) is issued as a receipt.
- 2. Besides consular fees, consular authorities and consular offices also collect taxes, duties and contributions in favour of third parties, as enacted by law. The collection of any of the above, regardless of the amount, is acknowledged by issuing a Payment Slip ( $\Gamma \rho \alpha \mu \mu \alpha \tau \epsilon i \delta \tau \rho \alpha \xi \eta c \epsilon i)$  as a receipt.
- 3. Taxes and duties in favour of the State or third parties are collected by issuing a Payment Slip ( $\Gamma \rho \alpha \mu \mu \dot{\alpha} \tau \epsilon_0 = 1000 \, \text{cm}$ ) as a receipt, regardless of the amount.

## Article 5 Consular royalties

- 1) For the employment of a permanent consular employee at the request of an individual or for private interest outside the consular premises, a fee of **EUR 150** per 4 hours or fraction thereof is collected in favour of the state by issuing a Payment Slip ( $\Gamma \rho \alpha \mu \mu \acute{\alpha} \tau \epsilon i \sigma \rho \alpha \xi \eta c$ ).
- 2) For interpretation services of a permanent consular employee in a civil or private case, a fee of **EUR 100** for every hour of actual interpreting service is collected in favour of the state by issuing a Payment Slip ( $\Gamma \rho \alpha \mu \mu \acute{\alpha} \tau \epsilon_{10} = 100$ ).
- 3) The fees of paragraphs (1) and (2) of this article are doubled in the event that the employee should travel outside the city where the consular authority is located.
- 4) For translations by permanent employees of consular authorities, the amount of **EUR 20** per page are collected in favour of the State.
- 5) In case of honorary consular authorities, the above royalties are collected by the heads or employees of the said consular authorities or the interpreters, as the case may be. The collection is made by issuing a simple receipt.

### Article 6

### Receipts of honorary consular authorities

- 1) The heads of honorary consular authorities withhold, to cover their operational needs, a percentage of 60% of their consular receipts and pay the balance of 40% to the state on submission of their accounts in accordance with the provisions applicable each time.
- 2) Taxes and roylaties in favour of the state or third parties, collected by honorary consular authorities, are paid in full.

3) In the event that the product of receipts of honorary consular authorities which is due to the state cannot be transferred abroad due to foreign exchange restrictions, it is forwarded at the end of the fiscal year, following the approval of the General Inspection of the Ministry of Foreign Affairs, to the embassy under whose jurisdiction the honorary consular authority is included.

### Article 7

### Repealed provisions

Presidential Decree 116/2002 (A' 96) as well as every other provision of administrative regulation which regulates matters dealt with herein in a different manner, are hereby repealed.

### Article 8

### Entry into force

The present Decree shall enter into force after the completion of one month from its publication in the Government's Official Gazette.

We entrust the publication and implementation of this Presidential Decree to the Minister of Foreign Affairs.
