**Subject: Invitation to submit an offer for a purchase and installation of a Communication Telephony Exchange System in the Chancery of the Embassy of Greece in New Delhi**

The Embassy of Greece in New Delhi, bearing in mind the provisions of Law 4412/2016, as amended and in force, is going to proceed with the purchase and installation of one (1) Communication Telephony Exchange System, for the communication and telephony needs of the Embassy, a budgeted expenditure of up to 14,10,108.00 Indian Rupees, (VAT included) the equivalent in Euros approximately 16.023 and invites interested parties to submit a relevant offer, in accordance with the attached table of technical specifications, for which it requests the faithful observance of reference.

The offer to be evaluated should include:

- a) The price, including reservations and VAT, as well as the total value of the services provided, i.e. the provision, installation, connection to existing telephone lines, testing and delivery of the devices in full and normal operation, which must not exceed its total budget.
- b) The relevant VAT.
- c) The duration of validity of the offer, which must be at least six (6) months.

The award criterion is the most economically advantageous offer based on price.

Bids can be submitted in paper or electronic form to the Embassy's secretariat until January 30<sup>th</sup> 2025.

Bids from economic entities that were not invited to submit a bid will not be considered.
