Subject: "Invitation to submit a tender for purchase and installation of 14 air conditioner units (13 of them in replacement and one new) in the building of the Consulate General of Greece in Jerusalem".

The Consulate General of Greece, in accordance with the Law 4412/2016, as amended, is going to proceed with a direct appointment and signing of a contract for: the purchase and installation of 14 air conditioner units (13 of them in replacement and one new) in the building (8 for the offices and 6 for the consulate residence) of the Consulate General of Greece in Jerusalem, of a **budgeted expense of 48.273,50 NIS** equivalent in euros approximately 12.070,00 (**prices without VAT**) or **56.480,00 NIS** equivalent in euros approximately 14.120,00 (**price including VAT**) and invites interested parties to submit a relevant offer, according to the attached table of technical specifications.

In order to be examined, any bid should include:

- The price per unit for each air conditioner unit and other materials, which will be used, as well as the total price.
- The cost of the services to be provided, for the removing of the thirteen old units and installation of the fourteen new ones.
- The total value should not exceed the total budget mentioned above.
- The corresponding VAT (if any).
- The deadline for the completion of the said project.
- The duration of the offer value.

The criterion for the selection will be the most economical price offer that fulfills the said specifications.

Technical specifications

- All air-conditioner units should include inverter technology in their functions.
- The output of each air conditioner unit (BTU) should be suitable for the space that it will be installed.
- All air-conditioner units should have self-cleaning function and air purification function and also classified in energy class A.
