Quarantine, exceptions, travel within 48 hours and the regime on the Czech-Slovak border from 4 June 2020


4.6.2020 | Travel notifications and alerts Coronavirus 2019-nCoV

According to the valid measure of the Public Health Office of the Slovak Republic, **all persons who enter the territory of the Slovak Republic from 00.00 on 27 May 2020** are ordered to be isolated in facilities designated by the state for the time necessary to perform laboratory diagnostics of COVID-19 or compliance with the ordered isolation.

Information on the launch and conditions of smart quarantine must be checked on the website before coming to the border

When entering the territory of the Slovak Republic with the eKarantena application activated, we recommend citizens to submit already completed forms "affidavit" and "consent to submit to the ordered isolation in the home environment using a mobile application."

In order to plan free capacities in quarantine centres as close as possible to the place of stay in Slovakia, it is necessary to register in advance, no later than 72 hours before the planned arrival at the Slovak border, in the registration form:

Isolation (state, domestic) is mandatory for any form of travel, whether individual or organized. Isolation in a state-designated facility lasts for the time necessary to perform a laboratory diagnosis of COVID-19, and subsequently, after a negative result is found, the person is ordered home isolation for a total total period of 14 days. During the period of such domestic isolation, domestic isolation is also ordered for persons living with it in the same household.

Isolation in state-designated facilities does not apply to the following persons:

- persons with reduced orientation and movement,
- pregnant women,

- persons with oncological, psychiatric illness, severe immune disorders, persons with special nutritional needs, persons with chronic respiratory, cardiovascular diseases, persons with metabolic disorders, persons with epilepsy, persons with mental disorders, persons with serious diseases requiring continued injectable treatment at regular intervals, severely disabled people. When entering the territory of the Slovak Republic, these persons are obliged to submit a certificate from a doctor provided with his / her signature and a stamp stating that their health condition falls under the above-mentioned health restrictions,
- persons over 75 years of age,
and to persons close to them and accompanying them at the time of crossing the state borders of the Slovak Republic, which from 27 May 2020 from 00:00 enter the territory of the Slovak Republic.


The above-mentioned persons and persons close to and accompanying are not covered by the Regulation on Isolation in Facilities Designed by the State, but may be isolated at home for 14 days provided that they submit a negative test result upon entering the Slovak Republic (confirmation of test negative) RT-PCR for COVID-19 disease not older than 96 hours. The obligation to submit the test result does not apply to persons under 3 years of age.

Persons under the age of 18 who enter the territory of the Slovak Republic unaccompanied are ordered to be isolated in the home environment for a period of 14 days. During the period of domestic isolation, this is also ordered for persons living in the same household;

All persons subject to the obligation of domestic isolation are obliged to report immediately by telephone to the locally competent regional public health office.

Persons enjoying diplomatic privileges and immunities are not subject to the obligation of state isolation, quarantine at home and also the obligation to submit the result of a negative test (confirmation of test negativity) by RT-PCR for COVID-19.

Detailed information concerning other categories of persons not mentioned above, e.g. commuters, health care workers and carers, pupils, students and accompanying persons are listed in the valid measure of the Public Health Office of the Slovak Republic.

Regime on the Czech - Slovak border from 4 June 2020

The obligation to quarantine (national, domestic) or submit a negative RT-PCR test for COVID-19 **does not apply from 4 June 2020**


- **all persons with permanent residence or temporary residence or persons staying in the territory of the Czech Republic or in the territory of the Slovak**

Republic who enter the territory of the Slovak Republic **through border crossings between the Slovak Republic and the Czech Republic;**

If these persons do not have a certificate of permanent or temporary residence, they must be able to prove the fact of staying in the territory of the Czech Republic or the Slovak Republic with at least two credible documents.

Examples of credible documents are:

- health certificate
- insurance, lease,
- employment contract,
- agreement of service,
- opening from the employer,
- title deed to real estate intended for housing,
- Trade Certificate,
- confirmation of payment of direct debit,
- opening an account in a bank,
- insurance contract.

Travel to certain countries with return to Slovakia within 48 hours

The obligation to quarantine (national, domestic) or submit a negative RT-PCR test for COVID-19 does not apply from 2 June 2020:


- **persons with permanent or temporary residence in the territory of the Slovak Republic, on return from Hungary, the Republic of Poland, the Republic of Austria, the Republic of Slovenia, the Republic of Croatia, the Federal Republic of Germany or the Swiss Confederation**, unless their stay outside the Slovak Republic exceeds 48 hours before return; compliance with the time limit, the said persons are obliged to prove to the member of the police force at the border control;


The obligation to quarantine (national, domestic) or submit a negative RT-PCR test for COVID-19 does not apply from 2 June 2020:

- **persons with permanent residence or temporary residence or persons staying in the territory of Hungary** who enter the territory of the Slovak Republic through border crossings between the Slovak Republic and Hungary, or between the Slovak Republic and the Czech Republic, if they do **not stay** in the Slovak Republic **for more than 48 hours**; these persons are obliged to prove to the member of the Police Force during the border control that the time limit has been observed and , **if they do not have a certificate** of permanent or temporary residence, to stay in the territory of Hungary with **at least two credible documents** (*e.g. health insurance card, lease agreement, employment contract, agreement on the performance of work,*

confirmation from the employer, title deed to residential real estate, trade license, confirmation of payment of collection, confirmation of opening a bank account, insurance contract).

Please note that the above exemption from the quarantine obligation applies to citizens and foreigners residing in the Slovak Republic when travelling to the territory of the Slovak Republic and does not affect the conditions of entry into other states. Before travelling abroad, it is necessary to check the conditions of entry into the country.
