Our LL.M. in International and European Law, taught entirely in English, builds on the very successful LL.M. Programme we have created in the Athens Law School in the past ten years. It is an intensive Master's Programme, which provides students with an in-depth understanding of International and European Union Law in both their theoretical and practical aspects.

The Programme covers a single academic year, in the course of which students must successfully complete two semesters of core, mandatory taught modules while conducting research, under the supervision of our Faculty, leading to an original item of written work in the form of a dissertation.

The LL.M. course starts on 1<sup>st</sup> October and lasts until the mid-June. The written or oral examinations take place in February and June, upon completion of each semester. Students may re-sit a failed examination in September following the end of the academic year. The Master thesis shall be submitted by 30 September of the year during which the spring semester takes place.

Revekka-Emmanouela Papadopoulou completed her undergraduate studies at the School of Law of the University of Athens (NKUA, 1988). She obtained a Licence Spéciale in European Law (Institut d'Etudes Européennes, Université Libre de Bruxelles, 1989), a Licence Spéciales in Administrative Law (School

of Law, Université Libre de Bruxelles, 1990) and a Diplôme de Doctorat in EU Law (School of Law, Université Catholique de Louvain, 1995). Since 2000, she is a member of the Department of International and EU Law Studies of the Athens School of Law. She is currently an Associate Professor and she teaches EU Law in the framework of the graduate, post-graduate and Erasmus program. Her courses include EU Institutional Law, EU Economic Law, EU Tax Law, Huan Rights Protection in the EU, and the Area of Freedom, Security and Justice (mainly EU Migration Law and EU Criminal Law). She was a Visiting Professor at the International Tax Center (Leiden) and she teaches EU Law at the National School of Public Administration. Her areas of interest focus on the principles and the functioning of the EU legal order and its relationship with national laws, the EU internal market (mainly issues of free movement and competition), EU tax law, human rights protection in the EU, the rules on the Economic and Monetary Union, and the Area of Freedom, Security and Justice (mainly migration, asylum granting and EU criminal law). She is the author of several monographs and articles and she has given lectures in the framework of national and international conferences. . Her PhD thesis was awarded a prize by the Hellenic University Association for European Studies (ESCA-Greece) and the Foundation for the Promotion of European Studies, for its contribution to the study of European integration. She participated as a senior researcher in the EU-funded projects ELISE (2002-2005) and CHALLENGE (2004-2008). She is a member of the Hellenic Association for European Law

Manolis Perakis completed his undergraduate studies at the University of Athens (2001) and his post-graduate studies at both the University College London (LLM, 2002) and the University of Athens (PhD, 2008). In 2003, he served as trainee in the Cabinet of the Greek judge and President of the Court Mr.

Vassilios Skouris. Manolis Perakis is currently teaching EU Law in the University of Athens as Assistant Professor. His areas of interest are EU institutional and internal market law, EU human rights protection law, EU external relations law, Economic and Monetary Union, and the EU Court of Justice case-law. He is the author of several monographs and articles, and he has given lectures in the framework of national and international conferences. Manolis Perakis also practices law as attorney-at-law. He is a senior associate in a law firm and he is actively involved in all public procurement and privatisation transactions, advising mainly on EU and administrative law aspects. Furthermore, he is involved in numerous ICC and local arbitrations as the Court's assistant. He has been Visiting Professor at the Institute of Air and Space Law of the McGill University (Montreal, Canada) as well as at the Faculty of Law Sophia-Antipolis of the University of Nice (France). He is admitted to the Bar of Athens, and also a member of the Board of Directors of the Hellenic Society of International Law and International Relations (2011-2017), member of the European Society of International Law, the point of contact (Greece) for the European Center of Space Law (ECSL) member of the Space Law Committee of the International Law Association (ILA); and a member of the International Institute of Space Law (IISL). Since 2016, Prof. Kyriakopoulos has been a Delegate for Greece at ICAO, UNCOPUOS and COSPAS-SARSAT, and since 2017, he has been *Rapporteur* to the Scientific Council of the Greek Ministry of Foreign Affairs.Areas of interest, for Prof. Kyriakopoulos, are Public International Law, International Organizations, Air Law, Space Law, International Telecommunications Law, Law of the Sea. He is the author of three monographs, two manuals and numerous papers and studies as well as volume editor for contributed books.



#### Anastasios Gourgourinis Assistant Professor of International Law

Assistant Professor of Public International Law at the Faculty of Law of the National and Kapodistrian University of Athens, specializing in International Economic Law. He is also a Research Fellow at the Academy of Athens and a membre associé of the Centre de Recher-

che sur le Droit des Marchés et des Investissements Internationaux de Dijon (CREDIMI), Université de Bourgogne. He holds an LL.B. and an LL.M from the Faculty of Law of the National and Kapodistrian University of Athens, as well as an LL.M. (awarded with Distinction) and a Ph.D. from University College London. Anastasios has served in the past as Special Legal Advisor at Greece's Ministry for Development and Competitiveness, and the Ministry of State, advising on issues pertaining to investment, trade and state aid. Currently, he practises with the Athens Bar in Greece. Anastasios' teaching and research interests include public international law, international investment law and WTO law, particularly from the perspectives of international arbitration and adjudication, the theory of sources of international law, State responsibility, and normative fragmentation of international law. He is the academic supervisor of the Summer Law School on International Investment Law, organized annually by the Athens Public International Law Center and ELSA Athens, convenes the Trade Law Clinic project, and coaches the teams which annually represent the National and Kapodistrian University of Athens in the Foreign Direct Investment International Arbitration Moot, the ELSA Moot Court Competition on WTO Law and the Willem C. Vis International Commercial Arbitration Moot.



#### Ilias Plakokefalos Assistant Professor of International Law

Ilias Plakokefalos is Assistant Professor at the Section of International and European Studies of the Department of Political Science and Public Administration NKUA. He holds an LLB from the

University of Essex, an LLM from Tulane University and a PhD from the National and Kapodistrian University of Athens. He has worked as a researcher at the University of Athens and for the UN Office in Geneva (International Law Commission). He was a post-doctoral researcher at the University of Amsterdam (2012-2015) working at the SHARES project. He has taught at the Universities of Athens and Amsterdam and has been a guest lecturer at the University of Oxford. His research interests include public international law, the law of international responsibility, international environmental law and the law of the sea.



#### Dr. Efthymios (Akis) Papastavridis

Efthymios (Akis) Papastavridis is a Researcher and Part-time Lecturer at the Faculty of Law of University of Oxford, and Oxford Martin Fellow at the Oxford Martin School, University of Oxford since April 2016. Dr Papastavidis is also Research Fellow at the Athens Public International Law Center, University of Athens, and

Teaching Associate at the Faculty of Law, NKUA. In addition, he works as Research Fellow at the Academy of Athens, Bureau of International Relations, under the supervision of Professor Emmanuel Roucounas, since 2010. He was formerly Expert Counsellor on Public International Law at the Ministry of Foreign Affairs, Greece (2016-2019); Parttime Lecturer at the Faculty of Law, Democritus University of Thrace (2010-2016) and Post-doctoral Fellow at the Faculty of Law, NKUA (2012-2015). Dr. Papastavridis has read law at NKUA and University College London. In 2009 he was awarded a PhD in Public International Law from University College London. He has taught public international law at various Universities in Greece and abroad; he has consulted international organizations and agencies, including the UN Office on Drugs and Crime (UNODC) and the UNHCR, on international law of the sea matters, and is currently consulting the UNODC and the European Border and Coast Guard Agency (FRONTEX). In 2012 Dr Papastavridis was the Director of the Centre for Research Studies of The Hague Academy of International Law. Dr Papastavridis is the author of three monographs, including The Use of Force in Afghanistan under International Law (Athens 2004), Interception of Vessels on the High Seas (Hart Publishing, 2013), The Protection of Shipping from Transnational Organized Crime (Athens, 2015); co-author of Public International Law Concentrate (Oxford University Press, 2013); editor of two collected volumes; and author of several

chapters in books and numerous articles. He has recently signed a contract with Oxford University Press for a monograph under the Oxford Monographs on International Law Series on 'Fisheries Enforcement and Marine Biodiversity under International Law'.



#### **Dr. Theodoros G. Iliopoulos**

Prof. Dr. Theodoros G. Iliopoulos is a professor of European environmental law at Hasselt University, and a postdoctoral fellow of FWO (Flanders Research Foundation) for his project "Quo Vadis Renewable Energy Support Law", which is being conducted in af-

filiation with Hasselt University and Ghent University. He has also worked as an adjunct professor of European energy law at the Brussels School of Governance (Free University of Brussels, Vesalius College), His main expertise lies in the promotion of renewable energy sources, energy regulation, and EU energy policy. He has studied law at National and Kapodistrian University of Athens (LLB in 2014). He has an LLM in "EU Law" from National and Kapodistrian University of Athens (2015) and an LLM in "Law and Economics" from Utrecht University ("cum laude", 2016). He completed his doctoral research on renewable energy law at Hasselt University, in collaboration with Maastricht University, and under the supervision of prof. dr. Bernard Vanheusden, in October 2021. He has been honoured with several international research grants and awards, such as the GCET Award "Young Researcher" for 2020 or the distinction "Wiley Top Cited Article 2020-2021" for his work "The EU's 2030 Climate and Energy Policy Framework: How net metering slips through its network".



#### Dr. Stavros-Evdokimos Pantazopoulos

Stavros-Evdokimos Pantazopoulos is a post-doctoral researcher with the Toxic Crimes Project of the Erik Castrén Institute at the University of Helsinki, and a Researcher with the Asser Institute. Stavros is also a Fellow with the Athens Public International Law

Center and a co-Convenor of the AthensPIL Discussion Group series. Formerly, he was the Legal and Policy Analyst of the Conflict and Environment Observatory, a UK-based NGO aiming to raise awareness of the environmental impacts of armed conflict. Stavros obtained his PhD degree in international law from the European University Institute and his scholarship focuses on the legal aspects of environmental protection during and after armed conflict. Stavros holds three LLM degrees in international law (University of Athens, LSE, EUI) and visited the University of Michigan Law School as Michigan Grotius Research Scholar. He has been a visiting researcher at iCourts and a Teaching Fellow at

the Euro-American programme of SciencesPo, Reims campus. Stavros has taught international law, human rights law, international humanitarian law, international environmental law, and law of the use of force. He has published in the fields of international environmental law, law of armed conflict, and autonomous weapons systems.



#### **Dr. Anastasios Brakatsoulas**

Anastasios Brakatsoulas was born in Athens in 1975. He studied between 1995-2003 in the UK: LL.B. at the University of Hertfordshire, LL.M. at the University of Manchester (EU law) and Postgraduate Certificate in Education (FE/HE) at Institute of Bolton. Between 2002-4 he taught at various colleges in the UK (Wilberforce College, MANCAT, St Anselms College). In 2006 he completed the academic recognition of his degrees in Greece (DIKATSA exams) and in 2007 he completed the

LL.M (EU Law) course at the National Kapodistrian University of Athens (NKUA). In 2021 he received his doctorate from NKUA in the field of European Union law. His thesis was titled: "National Constitutionalism and European Constitutionalisation in EU law" and it was published by "Nomiki Vivliothiki" publishers in 2022. All his dissertations have been awarded with grade distinction. Since 2021, he is assistant lecturer for the LL.M. program (EU law) of NKUA. He is a lawyer at the Athens Bar Association since 2007. He speaks fluently English and Bulgarian and Italian and Spanish at a very good level.



#### **Dr. Apostolos Samaras**

Apostolos Samaras is an Attorney at Law and Research Fellow at the Hellenic Foundation for European and Foreign Policy (ELIAMEP). He obtained his High School Diploma from the Marymount International School of Rome. He studied law and graduated (LLB, Law) from the School of Law of the National and Ka-

podistrian University of Athens (NKUA) in 2015, from which he also received his Master's Degree (LLM, European Law) in 2017. Then, he completed his Doctoral Studies with a scholarship from the State Scholarships Foundation ("IKY"). He holds a PhD (with distinction) in European Law from the School of Law of the NKUA (2021). Currently, he is a Postdoctoral Research Fellow & Teaching Assistant at the School of Law (Department of International Studies) of the NKUA, Adjunct Lecturer at the Hellenic Naval Academy (Cadets of the Hellenic Coast Guard), Visiting Lecturer at the Hellenic Naval War College. He is a member of the Editorial Board of the Greek legal journal "European Law", member of various scientific associations, author of many articles and other publications (in English & Greek) in reputable scientific journals. In addition, he is administrator of the scientific website of the Association of Scientists of European Studies. He delivers lectures

(in English and Greek) on various topics of European, International and Public law, he participates in educational activities and in the drafting/submission of research proposals. His main areas of research are: European Law and Governance, Economic Law, International Law, Public Law, Human Rights. He is the author of the monographs: "The restrictions on the free movement of capital in contemporary EU law" (Nomiki Bibliothiki, 2022, 480 pp.) & "The Primacy Principle of EU law: The cornerstone for maintaining the integrity of the autonomous EU legal order", (Nomiki Bibliothiki, 2023, 248 pp.).



#### Dr. Maria – Louiza Deftou

Maria-Louiza Deftou is a Research Fellow at Marangopoulos Foundation for Human Rights (MFHR) and an active researcher at the Athens Public International Law Center (AthensPIL) with a multifold involvement in academic life. She has participated in a number of EU-funded research and teaching projects: as a teaching

#### **Refugee and Migration Studies Summer School** July 2022

The inaugural Refugee and Migration Studies Summer School took place in July 2022and offered a unique experience to students interested in challenging contemporary migration issues. From simulations of rescue at sea to a meeting with the Greek Minister for Migration, from academic lectures by lawyers, environmentalists, journalists and emergency doctors to visits to refugee camps and cen-

ters for unaccompanied child refugees, 9 students from the National and Kapodistrian University of Athens and other European and US universities alongside 14 Harvard graduate students had the opportunity to hear and learn from 42 leading scholars, politicians, leaders of international organizations, civil society organizations and members of the local community. The program also welcomed two refugee participants and several students with refugee and irregular migration backgrounds, helping to partly realize tertiary education for distress migrants who often have little or no access to it. Three RMS Hub students, including the two refugee participants, received full or partial scholarships.



# Summer School in International Investment Law Athens (23.7.2023-30.7.2023)

The Summer Law School on International Investment Law, co-organized annually since 2016 by ELSA Athens and the Athens Public International Law Center (Athens PIL) of the School of Law of the National and Kapodistrian University of Athens, under the academic supervision of Assistant Professor Anastasios Gourgourinis, took place in Athens between July 23 and July 30, 2023. The *Summer* 

Law School on International Investment Law 2023 constituted of more than 32 hours of interactive lectures and workshops over 6 days, and provided participants with all the essential tools to grasp the key aspects of international investment law, while also addressing some of the currently "hottest topics" of the field. The Programme also featured a *Skills Training Workshop on Written and Oral Advocacy in Investment Arbitration* offered by ICDR Y&I.

## - Law Clinic



Trade Law Clinic (7 & 15.6.2023)

Trade Law Clinic project offers our students a unique opportunity delve into international trade and investment law by preparing legal reports (informative, advisory or ad hoc) on specified subjects of interest to participating project partners, which include governmental and non-governmental organizations and civil society institutions. The goal is for students to put international economic law theory into practice, so that the research generated takes into due account the actual needs and concerns of business and society stakeholders. In Trade Law Clinic 2023 presented their research conclusions and received comments by experts of the Economic and Social Council of Greece (OKE), including its President, Mr. Ioannis Paidas, Secretary General Mr. Apostolos Xyrafis, Head of International and Public Relations Dr Martha Theodorou and Scientific Advisor Mr. Dimitris Bimpas. This year's research focused on the very important topic of trade relations between the European Union and Africa law.

# International Moot Court Competitions



The Athens Law School and the Department of International Law participate each year in a series of national and international student Moot Court or Arbitration competitions, in the fields of Public International Law, Human Rights, Humanitarian Law, European Law, International Criminal Law, Roman Law, Space Law, Air Law, Commercial Law, Commercial Arbitration, International Commercial Arbitration and United Nations simulations, in which it has obtained a significant number of awards.

A Moot Court is a simulation of trial or arbitration, in which students compete in English, on a case involving complex legal issues, acting as lawyers representing the plaintiff, the defendant or the parties of an arbitration. They answer questions asked by the judges and challenge the arguments of their opponents. Some competitions also require the contestants to submit written memoranda or legal sources relevant to their argumentation. Law Professors and eminent legal practitioners are sitting as "Judges" in the competition. Competitors are graded on the basis of specific criteria and the best teams and speakers are awarded team and individual awards, as well as best written memoranda awards.

Prospective students who will be admitted to the LL.M. Programme in International and European Law might have the opportunity to experience a moot court competition. Therefore, they will be presented with the opportunity to cultivate their legal skills in a competitive and multicultural environment. This rare experience would see them becoming more competent within the global community of lawyers, familiarise themselves with the latest legal developments and also broadening their horizons by strengthening the cooperation between nations.

The outstanding achievements and distinctions received by our students in several international competitions rank the Athens Law School - regarding the total number of awards over the last years - among the best in the world. Some of our prizes include:

#### The Athens Law School team won the 1<sup>st</sup> place at All-European International Humanitarian and Refugee Law Moot Court Competition 2022-2023



Our team participated for the first time ever in this year's All-European International Humanitarian and Refugee Law Moot Court Competition and, following a tight and exciting final round against the Sofia University "St. Kliment Ohridski", was unanimously ranked first!

The NKUA team was composed of Despoina Papadela (undergraduate student), Polyxeni Dimopoulou and Spyridon Leonis (postgraduate students at the LLM in International and European Law) under the guidance of Dr. Stavros Evdokimos Pantazopoulos.

Polyxeni was also granted the award of the Best Oralist of the Final Round. The team members demonstrated their exceptional legal, role-playing, and public speaking skills throughout the various stages of this demanding Competition which they well-deservedly won.

The All-European International Humanitarian and Refugee Law Moot Court Competition is based on a Case Study which is carefully prepared by the organisers (University of Ljubljana, Faculty of

Law) in cooperation with the International Committee of the Red Cross (ICRC) and the United Nations High Commissioner for Refugees (UNHCR) and addresses the most topical questions relating to international humanitarian and refugee law, drawing on current situations. It is designed to encourage students to study and understand the fundamental concepts of international humanitarian and refugee law by addressing concrete legal problems and practice their legal argumentation in front of experienced judges and panel members.

The 7<sup>th</sup> edition of the prestigious All-European International Humanitarian and Refugee Law Moot Court Competition took place at the outstanding premises of the University of Ljubljana from the 15<sup>th</sup> to the 18<sup>th</sup> of November 2022. It was organized by the Faculty of Law, University of Ljubljana (Professor Vasilka Sancin) and supported by the ICRC, the UNHCR, and the Slovenian Red Cross. The hospitality and the excellent organization of the Competition ensure the NKUA's return next year. The NKUA team is grateful to Professor Vasilka Sancin and Dr. Maruša Veber for putting together such a fascinating Competition.

The NKUA team would further like to acknowledge and warmly thank the ICRC Athens Delegation for its constant care and tireless efforts. Without its indispensable support, it would be impossible for our team to participate in the Competition.
